- 九、本人知悉於研習結束後一個月內，須配合國際處依本校規定辦理經費核銷程序(紙本作業不得線上辦理)，逾期不予核銷。為配合年度關帳作業，核銷未於當學年會計室公告之關帳日前辦理完成，將亦不予受理，**若本人因個人因素超過核銷期限致無法請領補助，願自行負責，絕無異議。**
- 十、研習活動結束後，不得滯留境外，如有違反，除依校規處理外，學生須自負一切法律責任。

I confirm that I have read, understood, and agreed to comply with all the terms listed below:

1. I guarantee that I am in good physical and mental health to participate in this program. If I am unfit to travel, I will voluntarily withdraw.
2. The MCUT Office of International Affairs (OIA) handles only academic exchange and administrative services. Neither MCUT nor the host institution is responsible for my daily life or legal liabilities abroad.
3. During my time abroad, I will maintain good behavior, protect the reputation of both schools, and stay in close contact with my department and the MCUT OIA. If I break any rules leading to personal safety issues, financial loss, or legal violations, I will take full legal responsibility and accept punishment according to MCUT regulations.
4. I confirm that the program dates do not conflict with my academic progress, conduct, or other personal arrangements.
5. I must purchase sufficient travel insurance before departure (minimum coverage of NT\$ 3 million, including medical and accident coverage). The insurance must cover all travel days. If I fail to purchase insurance as required, MCUT reserves the right to disqualify me from the program.
6. (For Taiwanese male students only) I understand that students who have not yet completed mandatory military service must apply for short-term travel authorization through the National Conscription Agency website: <https://www.ris.gov.tw/departure/app/Departure/main>.
7. I understand that I must keep all original plane tickets, boarding passes, and receipts to apply for the financial subsidy.
8. Plane tickets are a contract between the student and the travel agency. If I cannot participate after the ticket is issued, I must cover any cancellation fees or refund losses myself. MCUT is not responsible for reimbursement.
9. I understand that I must complete the reimbursement process with the OIA in person (paperwork only, no online submission) within one month after the program ends. Late submissions will not be processed. If I cannot receive the subsidy due to personal delays, I will take full responsibility.
10. I will return immediately after the program ends and will not stay abroad illegally. If I violate this rule, I will face school disciplinary action and full legal liability.
11. For any matters not covered here, MCUT regulations apply. MCUT reserves the right to make the final interpretation of this document. If I have any questions, I will contact the OIA proactively.
